

## CTU Scholarship for Foreign Students of English Master's Degree Programme

Conditions and procedures for awarding scholarship to foreign students studying Master Degree Programme (MDP) at Masaryk Institute of Advanced Studies (MIAS), Czech Technical University in Prague (CTU). Director's order No. 13/2024.

The Order is in conformity with Act No. 111/1998 Sb., Higher Education Act, §91, para. (4) letter (b) of this Act, and in accordance with CTU Scholarship Rules, and rules of awarding scholarships to foreign students studying Master Degree Programmes at CTU.

- 1. The scholarship is intended for foreign students of MDP in English at MIAS who meet the criteria for awarding a scholarship.
- 2. The scholarship is a contribution towards covering the cost of a stay in the Czech Republic.
- 3. A student can apply for the scholarship from the second semester onwards; a first semester student can apply if his/her study immediately follow the study of Bachelor's Degree Study Programme in English at MIAS.
- 4. The scholarship is not claimable.
- 5. The scholarship is not intended for the CTU students of Erasmus and Erasmus Mundus programmes, CTU exchange students and government scholarship holders.
- 6. The applicant must apply in writing using a form that is available on the webpage of the rectorate of CTU <u>https://international.cvut.cz/students/incoming-students/ctu-scholarships/;</u> the application for the winter semester must be submitted by October 15th of the given academic year, and by March 9th for the spring semester of the given academic year.
- 7. The application must be submitted to email address <u>muvs-international@cvut.cz</u> together with the following documents:
  - a) A statement that the applicant has not been awarded any other scholarship,
  - b) Transcript of records of applicant's study results in previous semester of his/her Master's study; transcript of records of the final year of the bachelor study in English at MIAS (see point 3)
  - c) Motivation letter explaining reasons for applying for the scholarship
- 8. The applicant must not exceed the standard period of study, i.e. 4 semesters.
- 9. The applicant must have fulfilled all obligations towards MIAS before submitting the application (in particular, he/she must have paid the tuition fee)
- 10. The applicant's weighted average must be better than or equal to 1.7.
- 11. The scholarship is awarded up to an amount of 10 000 CZK per month and is financed equally from the scholarship fund of the rectorate of CTU and the scholarship fund of MIAS.
- 12. The maximum number of scholarships to be paid at MIAS is determined by the director of MIAS, as of September 30th and February 1st of the given academic year; the amount of the scholarship paid to a singular student is graded according to the study results of the applicants.
- 13. The scholarship is awarded for one semester. The student may apply for the scholarship repeatedly in the next semester.



- 14. A second-year student may be awarded scholarship for two semesters in case of excellent study results.
- 15. The scholarship is not paid in the summer months (July, August).
- 16. The scholarship does not limit the entitlement to a merit-based scholarship.
- 17. The students who have been awarded the scholarship are expected to cooperate in events organized by MIAS for future foreign students or newly admitted foreign students.

These conditions will come into effect on February 1<sup>st</sup>, 2025.
