

Conditions for the admission to the Bachelor Degree study programme for the Academic Year 2026/2027

1. Preamble

- This document sets forth the conditions for the admission to the full-time form of the Bachelor degree study programme ("BDSP") conducted in the English language at the Masaryk Institute of Advanced Studies ("MIAS") of the Czech Technical University in Prague ("CTU").
- 2. The admission to the BDSP is governed by Act No. 111/1998 Coll., Higher Education Act, as amended, and these Conditions.

3. Application procedure and deadlines

- 1. To be considered for the admission to the BDSP, applicants must have completed full secondary/high school Education (see section 4).
- The admission procedure is managed by the admission committee appointed by the director of the Institute.
- 3. An applicant enters the admission procedure by performing the following steps:

- a. filling out and submitting a completed electronic application form via application Přihláška ČVUT (https://www.prihlaska.cvut.cz) by February 28, 2026,
- b. paying the fee for the admission procedure (950,- CZK) via application Přihláška ČVUT (https://www.prihlaska.cvut.cz), or transfer to the bank account of MIAS (see Section 8 for details),
- c. delivering a fully completed all required documents to the MIAS International Office, either by post, electronic post or in person (see Section 4 for details and for the address of the International Office).
- 4. The deadline for completing all these steps is February 28, 2026. Applicants are strongly encouraged to perform these steps as soon as possible to allow the MIAS administration to process the applications on an ongoing basis.

4. Documents to be submitted by post, electronic post or in person

- 1. Applicants who have already completed their secondary/high school education at the time of submitting the application shall attach photocopies of official documents that:
 - a. demonstrate full completion of secondary/high-school education, and
 - b. indicate studied subjects and obtained grades, and
 - c. indicate the subjects and results of the graduation exam (if applicable).
- 2. The above requirements can be usually fulfilled by submitting an appropriate combination of the following documents:
 - a. secondary/high-school-leaving certificate, and/or
 - b. official secondary/high-school transcripts, and/or
 - c. annual grade reports from all years of the secondary/high school, and/or
 - d. graduation exam certificate.
- Applicants who are studying in their last year of secondary/high school at the time of submitting the application shall attach photocopies of official documents that indicate so far studied subjects and obtained grades.

The above requirement can be usually satisfied by submitting the following documents:

- a. annual grade reports from the last three completed years of the secondary/high school, and
- b. a mid-term grade report from the current year, and/or
- c. official secondary/high school transcripts.
- 4. Applicants who are studying in their last year of secondary/high school at the time of submitting the application will be required to submit documents that prove successful completion of their secondary/high school studies later, at the registration into the BDSP at the latest.
- 5. A photocopy of the applicant's passport (open on the page with his/her photograph and identification data).
- 6. During registration at the MIAS International Office, applicants must present the originals of all submitted documents for verification.
- 7. All documents that are not in Czech, Slovak, or English shall be accompanied by a certified translation into Czech, Slovak, or English. A photocopy of the translation shall be scanned and sent by email or post, the original documents shall be presented during registration at the MIAS International Office.

8. The documents shall be scanned and sent by email to muvs-international@cvut.cz or delivered by post (it is recommended to use traceable mail) or uploaded to the portal https://www.prihlaska.cvut.cz or submitted in person to the following address:

5. Admission exam (test and interview)

- 1. Admission exam consists of a written test and an interview. The written test has two parts:
 - test from mathematics (10 points),
 - · test from English language (25 points).

The scope of the test and the specimen of the test will be published on http://www.muvs.cvut.cz.

- 2. The Admission Test Invitation will be sent to the email address given on the application form. The tests from English and mathematics will be conducted online using Moodle platform.
- 3. After the admission test a 15-minute online interview with the applicant will be conducted. The aim of the interview is to assess language knowledge (comprehension and expression) of an applicant and to verify his/her interest to study Business and Economics. Questions from World economics terminology, company organization terminology and specifics of EU as FTA will be asked by the commission.
- 4. If an applicant is resident in the Czech Republic at the time of interview, he/she can conduct the interview in person at MIAS after agreement by the admissions committee.
- 5. Applicants are expected to have a good command of spoken and written English at least at B2 level which will be verified during the test. The level of spoken English knowledge is assessed during online interviews with the members of the admission committee.
- 6. The director of MIAS will forgive the obligation to pass the English language test to those applicants who:
 - a) are native speakers and completed their secondary education in English
 - b) completed university education in English
 - c) completed University Preparatory Programme at MIAS and successfully passed final certified exam from English
- 7. The director of MIAS will forgive the obligation to pass the test from mathematics to those applicants who completed University Preparatory Programme at MIAS and successfully passed final exam from mathematics
- 8. The applicants who will be exempted from the English language test or test from mathematics will automatically obtain maximum possible score from the relevant part i.e. 25 points from English and 10 points from mathematics; these applicants will have to pass the exam from the remaining two parts of the admission test. The aplicants who will be

- exempted both from English language test and test from mathematics will have to pass the Interview only.
- 9. The technology required for the online admission (interview) is a device with a camera and microphone and installed web browser supporting the WebRTC technology (recommended browsers are Chrome and Firefox). It is the responsibility of each applicant to ensure access to such technology.
- 10. The tests and interviews will take place from March 9th to March 20th, 2026. A week before, the applicant and the admissions committee mutually agree upon the exact date and time of the online test and interview using email, phone calls, Skype sessions, or any other mean of electronic communication. All the details to online test together with access data to Moodle will be sent to the applicants by email in time.
- 11. Time limit for whole admission test is 60 minutes. The maximum number of points that can be achieved is 35 in whole test.
- 12. The interview is evaluated with a maximum of 10 points.
- 13. An applicant will be preliminarily admitted to the study if he/she:
 - a) fulfils the conditions of the CTU Admission Procedure Rules, and
 - b) obtains at least 5 points from mathematics, 13 points from English and 5 points from the Interview, and
 - c) obtains at least 27 points from whole admission test.
- 14. The director of MIAS may announce an extraordinary admissions date for other applicants interested in studying at MIAS.
- 15. The applicants will be notified of preliminary admission/non-admission via email within a week after the admission exams ended.

6. Tuition fee, study contract and other arrangements

- 1. A necessary condition for preliminarily admitted applicants to be officially admitted is the payment of tuition fee of 38 000 CZK for the first semester of the academic year to the bank account of MIAS, see Section 8. The payment request (Billing Details) will be sent to the successful applicant by email together with the preliminary admission decision.
- 2. The tuition fee must be paid by the date indicated on the Billing Details, but no later than April 17, 2026.
- 3. At the moment the payment is made by the preliminarily admitted applicant, he/she needs to fill out the study contract form and send it to MIAS International Office via email. The study contract form is available online at Masarykův ústav vyšších studií ČVUT v Praze Admission procedure (cvut.cz).
- 4. Upon receipt of the tuition fee payment to the bank account, MIAS will confirm the receipt by email and issue an official letter of admission within five days after the receipt of the tuition fee payment.

- 5. At the same time, a signed and stamped study contract will be sent back to the applicant via email. The original will be signed by the admitted applicant during the registration into BDSP (see Section 9). Each Party will keep one copy of the contract.
- 6. The official letter of admission, that must be submitted to visa application at the Czech Embassy in the applicant's country, will be sent to the applicant via Česká pošta (Czech Post) by registered mail. The date of delivery and notification of the decision in this way is considered to be the date indicated by Česká pošta on the certificate of delivery.
- 7. The applicants who agreed to receive the letter of admission via application Přihláška ČVUT, will receive the document in this way.
- 8. The applicants with visa requirements will be asked, before the official letter of admission is sent, whether they would like to use faster delivery via courier service. The courier service must be ordered by an applicant and all costs associated with the delivery of the consignment must by borne by the applicant. MIAS is obliged to prepare the consignment at time announced in advance; the date of delivery and notification of the decision in this way is considered to be the date indicated by courier service.
- 9. Admitted applicants are obliged to inform MIAS about the submission of a visa application within 3 weeks after receiving the official document confirming admission to study.
- 10.Admitted applicants can book their accommodation in the CTU student dormitories at https://www.suz.cvut.cz/en/documents and will receive accommodation confirmation needed for the visa application.

7. Recognition of previous education/studies (Nostrification)

- Admitted applicants who have completed the required education at the secondary schools/Universities abroad, may be enrolled in the study programme only if their previous education is oficially recognized in the Czech Republic (unless otherwise stipulated by the International treaty to which the Czech Republic is bound). The confirmation of recognition of previous education must be submitted at the latest when registering for the BDSP.

- 3. An application for the recognition of previous education/studies must be submitted online (see 7.2) no later than 30 days before the date of enrolment into study at MIAS.

8. Fee payments

- 1. The admission procedure fee is non-refundable.
- 2. The tuition fee is non-refundable, except for serious circumstances that prevent the admitted applicant from registration (such as failure to obtain the visa to the Czech Republic or Nostrification with an exception of negligence on the side of applicant (f. e. failure to deliver documents required by the Authorities)). In cases beyond applicant's control, the applicant shall submit a request and supporting evidence to the Director of MIAS who then decides about returning the fee.

- 3. The tuition fee does NOT cover accommodation, food, transportation, books, medical insurance, or other personal expenses.
- 4. All payment should be made by wire transfer. All transactions and charges associated with the payment shall be borne by the applicant.
- 5. An admitted applicant shall transfer the money to one of the following accounts and always use the instruction for international payments so that MIAS receives full amount.

9. Registration into BDSP

- 1. Admitted applicants must come in person at MIAS International Office during two weeks preceding the beginning of the Academic Year in order to register into BDSP. The exact place and time of the registration will be specified in email communication with admitted applicants.
- 2. During registration at the MIAS International Office, applicants must present the originals of documents attached to the application for verification and the document confirming the Recognition of previous education/studies (see section 7).
- 3. Applicants who cannot attend the registration at the designated time due to serious reasons must inform the MIAS International Office by sending an email to muvsinternational@cvut.cz. For such applicants another registration date will be arranged individually. Applicants who fail to attend the registration into BDSP and fail to inform the MIAS International Office will not be registered.
- 4. If the applicant is unable to register for serious reasons by October 12, 2026, he/she cannot start the study.
- 5. If the applicant could not start the studies for reasons beyond his/her control, he/she may be admitted to study the following academic year, provided that he/she retakes the admission exams. Such an applicant doesn't have to repeat the admission interview.

10. Concluding remarks

1. Information stated in the application Přihláška ČVUT https://www.prihlaska.cvut.cz and application attachments must be true and complete. False or incomplete information can

result in a rejection of the application form during the admission procedure and if discovered after the registration into the study programme, in a possible exclusion from the studies.

- 2. MIAS reserves the right not to open the study programme if fewer than 5 students enrolled. In such a case, the tuition fee will be refunded in full.
